

**SUMMARY ANNUAL REPORT FOR  
ROHLIG USA, LLC  
WELFARE BENEFITS PLAN**

This is a summary of the annual report of the Rohlig USA, LLC Welfare Benefits Plan (Employer Identification Number 05-0571582, Plan Number 501) for the plan year January 1, 2018 through December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has insurance contracts with BlueCross BlueShield of Illinois, Dearborn National Life Insurance Company and Vision Service Plan to pay all life, accidental death & dismemberment, medical, dental, vision, temporary disability and long-term disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2018 were \$2,816,552.
